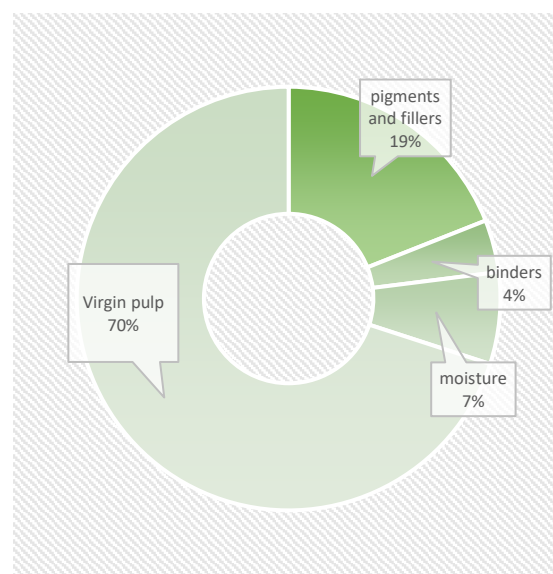

Mill Environmental Objectives 2025

Create a more even raw water purification and smoother reject to the river by installation of new purification equipment for incoming water.

Reduce energy use through specific measures. For example, speed control at drives, low-load stop pulper, optimize hot water use, limit heat dumping etc.

Reduce the proportion of combustible waste by systematically prevent interruptions and errors, launch concepts with pulse boards and improvement measures.
